XII. SEQRA Declaration

Motion by Kathy Swezey, seconded by Carin Shaffer, that the following resolution be approved,

WHEREAS, on January 17, 2017, The Board of Education (Board) of the Windsor Central School District (WCSD) passed a resolution entitled: RESOLUTION- INTENT TO DECLARE LEAD AGENCY STATUS WINDSOR CENTRAL SCHOOL DISTRICT- 2017 DISTRICT WIDE

CAPITAL PROJECT, which was item XI on the agenda (hereinafter referred to as "the January 2017 SEORA Resolution";

WHEREAS, upon closer inspection, the District realizes that it declared the project as a Type I action when in fact it does not rise that level; upon closer review of the previously provided Project Scope and Budget Summary the project does not involve the physical alteration of 10 acres or involved any other action or combination of the actions that makes this project qualify as a Type I action; but rather several of the proposed actions are unlisted or could even be considered type II actions under SEQRA; WHEREAS, WCSD is still proposing to undertake the project, which consists of various site improvements, furnishings, equipment, machinery, apparatus, appurtenances, material replacements, and other improvements to existing buildings and costs incidental thereto;

WHEREAS, the Board has caused a full Environmental Assessment Form (EAF) to be prepared for assessing the potential adverse environmental impacts that may result from the adoption of this proposed action;

WHEREAS, the Board has carefully considered the nature and scope of the proposed action, and it wishes to fully comply with its obligations under SEQRA and the regulations thereunder with respect to the proposed action;

WHEREAS, pursuant to the Regulations, the Board has considered the significance of the potential environmental impacts of the Project by (a) using the criteria specified in Section 617.7 of the Regulations, and (b) examining the EAF, together with other available supporting information, to identify the relevant areas of environmental concern, and (c) thoroughly analyzing the identified areas of relevant environmental concern; and

NOW THEREFORE, BE IT

RESOLVED, that the WCSD Board repeals the January 2017 SEORA resolution;

RESOLVES, that the action is not located in an agricultural district, that this is not a coordinated review and that the WCSD Board hereby is Lead Agency for the SEQRA review of this project; RESOLVES, the proposed action is an action not identified as a Type I or type II action under 6 NYCRR 617 and thus is an Unlisted action within the meaning of 6 NYCRR 617.2(ak) and therefore is subject to review under SEQRA and the regulations thereunder;

FURTHER RESOLVES, after review of the EAF and after a discussion about the environmental impacts of the proposed project, the WCSD Board finds that the proposed action will not have a significant adverse impact on the environment based on the criteria contained in 6 NYCRR § 617.7(c), and is not otherwise a Type I action as defined by 6 NYCRR § 617.;

AND LASTLY RESOLVES, This Resolution shall take effect immediately.

XIII. Approve Notice of Special Meeting for Capital Improvement Project

PLEASE TAKE NOTICE that a Special School District Meeting of the Windsor Central School District, Broome County, New York, will be held on April 11, 2017 (the "Election Date") at 10:00 o'clock A.M., at the polling places hereinafter specified, in Windsor, New York, at which the polls will be kept open between the hours of 10:00 o'clock A.M. and 8:00 o'clock

P.M., Prevailing Time, for the purpose of voting by voting machine upon the following propositions:

PROPOSITION NO. 1 - BOND PROPOSITION

Shall the following resolution be adopted, to-wit:

RESOLVED, that the Windsor Central School District, Broome County, New York, is hereby authorized to construct improvements to and reconstruct various School District facilities in and for said School District, including original furnishings, equipment, machinery, apparatus, appurtenances, and site (including athletic field and playgrounds) and incidental improvements and expenses in connection therewith, at a maximum estimated cost of \$14,150,000, and that \$1,895,000 of Capital Reserve Fund monies and \$1,505,000 other monies of the School District shall be expended therefor and the remaining \$10,750,000 or so much thereof as may be necessary after receipt of State aid, shall be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by Section 416 of the Education Law; and in anticipation of such tax, obligations of said School District shall be issued.

PROPOSITION NO. 2 - NEW CAPITAL RESERVE FUND

Shall the following resolution be adopted, to-wit:

RESOLVED, that the Windsor Central School District, Broome County, New York, is hereby authorized to establish a capital reserve fund pursuant to Section 3651 of the Education Law to be designated "Buildings and Facilities Improvement Reserve Fund" in order to pay the cost of the construction of improvements to and reconstruction and construction of various School District buildings and facilities, including original furnishings, equipment, machinery, apparatus, appurtenances, and site and incidental improvements and expenses in connection therewith, at an ultimate amount of \$10,000,000, plus accrued interest and investment earnings, with a probable term of ten (10) years, the source of funding to be surplus dollars when it closes its books every June 30 and/or legally available funds available to the District.

NOTICE IS HEREBY FURTHER GIVEN that due to space constraints on the voting machines, said propositions may be presented in substantially the following abbreviated form on the ballot of the voting machines used at such School District Meeting:

BOND PROPOSITION NO. 1 - BOND PROPOSITION

Shall the following resolution be adopted, to-wit:

RESOLVED, shall the Windsor Central School District, be authorized to construct improvements to and reconstruct various School District facilities, including incidental expenses, at a maximum estimated cost of \$14,150,000 with \$1,895,000 Capital Reserve Fund monies and \$1,505,000 other monies, and that the remaining \$10,750,000, or so much thereof as may be necessary, shall be raised by the levy of a tax upon the taxable property of said District and collected in annual installments as provided by Section 416 of the Education Law; and in anticipation of such tax, obligations of said District shall be issued.

PROPOSITION NO. 2 - NEW CAPITAL RESERVE FUND

Shall the following resolution be adopted, to-wit:

RESOLVED, that the Windsor Central School District is hereby authorized to create a new capital reserve fund not to exceed \$10,000,000 for a 10-year period for the improvement/reconstruction/construction of various School District buildings and facilities of which the source of funds will be general fund surplus as it may become available.

In the event that an abbreviated version of a proposition is necessary due to space constraints on the voting machines, a copy of the full text of said propositions shall be on file in the office of the School District Clerk, where the same is available for inspection by any interested person during regular business hours and shall be posted at the voting location.

SEQRA DETERMINATION. The School District has acted as lead agency under the State Environmental Quality Review Act regulations of the State of New York. The facilities capital project herein authorized has been determined to be an "Unlisted Action" in part, and a "Type II Action" in part pursuant to the regulations of the New York State Department of Environmental Conservation promulgated pursuant to the State Environmental Quality Review Act ("SEQRA"), the implementation of which as proposed, it has been determined will not result in any significant adverse environmental impact. SEQRA compliance materials are on file in the Office of the School District Clerk and are available for public inspection during regular business hours.

PERSONAL REGISTRATION.

NOTICE IS ALSO HEREBY GIVEN that pursuant to Section 2014 of the Education Law, personal registration of voters is required, and no person shall be entitled to vote at said meeting whose name does not appear on the register of said School District or who does not register as hereinafter provided, except a person who is otherwise qualified to vote and is registered under the provisions of Article 5 of the Election Law. The School District shall prepare a register for said Special District Meeting, except that the register prepared at the last annual meeting or election shall be used as the basis therefor and shall include all persons who shall have presented themselves personally for registration thereat and also all persons who shall have been previously registered hereunder for any annual or special district meeting or election and who shall have voted at any annual or special district meeting or election held or conducted at any time within four years prior to the preparation of said register.

NOTICE IS ALSO HEREBY GIVEN that the School District has established a new system of voter registration. Qualified persons may register to vote during the hours of 1:00 p.m. and 3:30 p.m. on regular days of business at the office of the District Clerk located in Windsor High School, 1191 NY Route 9, in Windsor, New York. Any qualified person will be entitled to have his or her name placed on the voting register. As a basis for preparation of the register, the School District shall use the Broome County register of qualified voters and the register prepared for the annual School District Election held May 17, 2016. Any qualified person 18 years of age or older, and a citizen of the United States and a resident of the School District for 30 days next preceding the date for voting is entitled to register and vote. Any qualified person who has previously registered for any annual or Special School District meeting or election and who shall have voted at any annual or Special School District meeting or election during the four calendar years prior to 2017, and any qualified person whose name appears on the register of qualified voters provided to the School District by Broome County, will not be required to register personally for this District meeting.

NOTICE IS FURTHER GIVEN that upon its completion the register will be filed in the office of the School District Clerk, located in the District Offices, 1191 NY Route 79, Windsor, New York where the same shall be open for inspection by any qualified voter of the District on each of the five days prior to and the day set for the vote, between the hours of 8:00 o'clock A.M. and 4:00 o'clock P.M., Prevailing Time, *except* Sunday, April 9, 2017.

ABSENTEE BALLOTS. *NOTICE IS ALSO HEREBY GIVEN* that applications for absentee ballots may be applied for at the office of the School District Clerk. Any such application must be received by the School District Clerk at least seven days before the date of the aforesaid Special District Meeting if the ballot is to be mailed to the voter, or the day before such Special District Meeting, if the ballot is to be delivered personally to the voter. A list of all persons to whom absentee voter's ballots shall have been issued shall be available for public inspection in the office of the School District Clerk not less than five days prior to the date of the Special District Meeting (excluding Saturdays and Sundays) during regular office hours until the date of the aforesaid Special District Meeting. In addition, such list shall also be posted conspicuously at the places of voting during the hours of such Special District Meeting. Absentee ballots must be received by 5:00 P.M. on date of election in the office of the School District Clerk.

XIV. Approve Establishment of a Capital Reserve Fund

BE IT RESOLVED, by the Board of Education of Windsor Central School District, Broome County, New York, as follows:

Section 1. Pursuant to Section 3651 of the Education Law, there is hereby established a reserve fund in and for Windsor Central School District, Broome County, New York, which shall be designated as the "Buildings and Facilities Improvement Reserve Fund" of said School District.

Section 2. Such Reserve Fund is hereby established for financing, in whole or in part, the following objects or purposes of said School District:

The construction of improvements to, additions to, and reconstruction and construction of School District buildings and facilities, as well as original furnishings, equipment, machinery, apparatus, appurtenances, and site and incidental improvements and expenses in connection therewith.

Section 3. The ultimate amount of such Reserve Fund shall be \$10,000,000 (plus accrued interest and investment earnings thereon).

Section 4. The probable term of such Reserve Fund shall be ten (10) years. Section 5. The source from which additional funds for such Reserve Fund will be obtained is as follows: surplus dollars as unappropriated fund balance available to the District when it closes its books every June 30, "surplus" intended to mean the difference between revenues and expenses in the General Fund, and other legally available funds to the District.

Section 6. This resolution shall take effect upon the approval thereof by a majority of the qualified voters of said School District voting on a proposition therefor submitted at the Special District Meeting Election to be held on April 11, 2017, the details of such proposition to be specified by a further resolution of this Board of Education. Section 7. The form of the proposition and notice thereof to be so submitted shall substantially be as provided in said further resolution.

Section 8. This resolution shall take effect upon the approval of the aforesaid proposition and, upon approval of such proposition, no further action of this Board of Education will be required to perfect the establishment of such Reserve Fund.
